

# Boards and Commissions Leadership Institute 2017 Priority Seats

(Updated 1/30/2017)

The priority boards and commissions that are best suited to influence equity are described below, arranged geographically as follows: City of Sacramento, County of Sacramento, City/County of Sacramento Joint Authority, and Other. Some of these entities allow youth to apply, or have reserved seats for youth.

An organization may nominate candidates toward one or more seats on this list. An organization may also nominate:

- A candidate to a seat not on the list, as long as the organization can articulate its interest in the seat and the ability to support the candidate if appointed to the seat. The organization should, in its nomination letter, articulate how the seat fits in with the issue areas of land use/built environment, housing, transportation, health equity, youth opportunity, or a combination of the areas. The seat should be within the six county Sacramento region (El Dorado, Placer, Sacramento, Sutter, Yolo, and Yuba counties); if outside the cities and counties listed in the opening paragraph, please also include in the nomination letter how the organization can support the candidate in the appointment process.
- A recently seated commissioner to a board or commission on the list, or not on the list and meeting the above requirements.
- A candidate that your organization is already assisting to apply for a seat on this list, or not on the list and meeting the above requirements.

## **City of Sacramento**

#### City of Sacramento Parks and Recreation Commission

- Meetings are held monthly no fewer than 8 times a year. Time and place TBA. Meets monthly on the first Thursday at 6:30 PM in the 2<sup>nd</sup> Floor Hearing Room of Historic City Hall at 915 I Street.

- There are 11 seats. Terms are 4 years.

The commission provides recommendations and advice to the City Council and the Department of Parks and Recreation on policies, projects, and other matters pertaining to parks, recreation, trees, and human services affecting the City of Sacramento referred to the Commission by the City Council, the Director of Parks and Recreation, the community or members of the Commission.



## **City of Sacramento Planning and Design Commission**

- Meets twice monthly on the 2<sup>nd</sup> and 4<sup>th</sup> Thursdays of the month at 5:30 PM in the Council Chambers at New City Hall, located at 915 I Street.

- There are 13 seats. Terms are 4 years.

This commission is charged with the following tasks: develop and maintain the General Plan and specific plans as may be necessary; make recommendations to the City Council on zoning ordinance amendments, zone changes, tentative subdivision and parcel maps; make environmental impact report recommendations and determinations on various projects; act upon applications for special permits and variances, and other functions the city council provides.

#### **Measure U Advisory Committee**

For each fiscal year in which Measure U half-cent transactions and use tax is collected, the committee shall review the City's independent audit report, prepare and submit to council a report recording revenue generated and how the revenue was allocated. This committee will sunset on June 30, 2020.

## **Sacramento Community Police Commission**

The commission is established for the purpose of providing recommendations to the mayor and city council on bias-free policing and the implementation, evaluation, and sustainability of efforts intended to strengthen community-police relations.

#### **Sacramento Youth Commission**

- There are 22 seats. Terms are 2 years. Eligible applicants must be between 14 and 19 years old.

The Sacramento Youth Commission is a youth led commission/advocacy group whose mission is to protect, preserve, and enhance the quality of life for Sacramento youth by advising the City Council and the public on issues relating to youth policies, programs, and opportunities.

# **County of Sacramento**

• There are 30 seats. Terms are three years, and one year for youth. There are two youth seats.

The purpose of this Coalition is to serve as an advisory board to the Board of Supervisors on matters related to the needs of children and families in Sacramento County.

#### **County of Sacramento Human Services Coordinating Council**

This council serves as an advisory body to the Board of Supervisors on matters relating to health and human services planning and policy issues.

## **County of Sacramento Planning Commission**

The Sacramento County Planning Commissions is a five-member commission appointed by the Board of Supervisors to hear land use, zoning and related policy issues. Some actions taken by the County Planning Commission are final unless appealed to the Board of Supervisors. This typically applies to smaller or single-entitlement applications such as rezones, use permits and variances. Some actions are sent as recommendations to the Board of Supervisors for final deliberation; these would include land use policy issues such as community plan amendments, general plan amendments and multi-entitlement applications.

Sacramento County Public Health Advisory Board has as its primary role advising the Board of Supervisors and/or the Human Services Coordinating Council in all major policy matters concerning the nature, scope and extent of public health. In that role the PHAB identifies local needs and priorities, encourages the development of appropriate services, and acts as a forum for issues regarding public health and primary care.

## **County of Sacramento Recreation and Park Commission**

The committee is charged with overseeing the implementation of the adopted 2010 Sacramento City/County Bikeway Master Plan. The duties of BAC will include advise staff and Council/Board on implementation of bicycle facilities included in the Bikeway Master Plan; assist in program development in areas of bicycle safety, education, registration, law enforcement, etc.; review and discuss current bicycling issues and advise staff and Council/Board; determine need for periodic updates of Bikeway Master Plan and assist in preparing updates and presentation; and provide for public participation and involvement with respect to bikeway implementation, programs and other bicycling matters addressed by the Committee.

#### **Sacramento Environmental Commission**

The commission advises the City Council and the Board of Supervisors with respect to needs for effective implementation of an environmental management program; aids and advises the Sacramento County Environmental Management Department in the formulation and implementations of its programs, including consideration of air quality, environmental health, and hazardous materials control within the boundaries of Sacramento County; assesses the impact of state and federal requirements and regulations; reviews and approves contents of proposed ordinances, rules and regulations.

#### Sacramento Housing and Redevelopment Commission

The commission acts as a community redevelopment commission under the Community Redevelopment Law of the State of California, and as a community housing commission under the Housing Authority Law of the State of California, serving as an advisory panel to the Sacramento City Council and County Board of Supervisors on matters related to redevelopment and Housing Authority projects, programs and activities.

#### **Sacramento Regional Transit District Mobility Advisory Council**

The object and purpose of the Mobility Advisory Council is to advise RT on system accessibility features and improvements, provide communication between RT and key stakeholder groups whose interests are representing persons with disabilities and older adults, and represent public transportation interest areas for persons with disabilities and older adults. The Council's annual work plan links accessibility issues with larger customer-oriented decisions, such as fare changes, customer information, and service plans.
